Comments from Visitors: Dr. Tunney asked if anyone wished to address the Trustees. There were no comments from visitors.

SPECIAL BUSINESS:

Awarding of Construction Contract for the Student Services Building:

Mr. Page asked what would happen if the Board chooses not to award this bid. Joe Demko, Kitchell Project Manager, was asked by President Garrison to address this question and provide a recap of the Student Services Building bid process. Mr. Demko spoke of the formal bidding process and that it is not uncommon in construction for bidders to protest the bid awarded. All eleven bidders were advised by Kitchell of the bid outcome, and the deadline to protest the bid has passed. The building will take sixteen months to build with completion anticipated by November, 2010.

That the Governing Board award the construction contract for the Student Services Building to Swinerton Builders in the amount of \$7,099,000.00.
