### 13. REPORTS AND PRESENTATIONS

A. Institutional Report: No report.

B. Superintendent/President's Report: Dr. Walter Tribley

Dr. Tribley reported that this year's commencement was the largest in the history of the college, with 261 students who walked in the graduation ceremony. / He recounted his statements at a recent Gentrain Board meeting, noting that he assured their members that there will be funding mechanisms in place to sustain Gentrain regardless of changes at the state level. MPC Foundation Executive Director, Ms. Beccie Michael, who accompanied him to the meeting, spoke about providing structure for their funds. / He lauded the Alumni Committee's recent sold-out event dedicated to the role of sports in society, which featured moderator Jim Tunney, as well as Herm Edwards and Ron Rivera. / He reported on the recent meeting of the Citizen's Bond Oversight Committee (CBOC), during which they toured MPC's facilities. / He stated that the District decided to search for an Interim Vice President of Student Services and that a decision regarding the Vice President of Administrative Services would be forthcoming within the next 24 hours. / He reported that candidates for the Gender & Women Studies position are in the process of being interviewed.

C. Vice Presidents' Reports:

Interim Vice President of Administrative Services, Mr. C. Earl Davis

Mr. Davis deferred his comments until his report on the tentative budget.

Interim Vice President of Student Services, Mr. Martin Johnson

Mr. Johnson highlighted items from his report, which may be reviewed under "Reports." / He elaborated on student success, noting that the state is looking to reduce the 3:1 required match in student success to 2:1. He informed the trustees that the student success plan is due in October and that the equity plan will be brought before the Board in October. He also reported that MPC received approximately \$1.7 million next year to support student success. He cautioned that there is a possibility that those funds could be reduced if there is a recalculation of FTES and if MPC doesn't meet all of the goals of student success. / He expressed his gratitude to Dr. Tribley and the trustees for allowing him the opportunity to serve MPC once again, and to the students, administrators, managers, faculty, and staff (particularly in Student Services), for a phenomenal learning experience. The trustees thanked Mr. Johnson for his service and expressed their appreciation for his leadership.

Academic Affairs Report, Dr. Walt Tribley

Dr. Tribley extended his thanks to Dr. Pinet for her service to MPC and particularly to her staff. / He reported that Basic Skills is funding a comprehensive math instructional support project this summer. Seven Basic Skills math classes have a trained individual to assist students in the Math Learning Center. The success of students learning via this model will be compared with last year's success rates. / He reported that the Fire Academy graduated twenty-one out of twenty-three cadets. Twenty-seven students are enrolled in the next Fire Academy, which will begin on July 10, 2014. / He reported that the Police Academy currently has 35 recruits enrolled. Their graduation will be on September 16, 2014. The next Police Academy is scheduled to begin on November 3,

2014. / He acknowledged the work of Ms. Beccie Michael, her staff at the MPC Foundation, and the MPC instruction team for their work on a \$175,000 grant proposal to support a Gender and Women's Studies faculty member on our campus. / He praised the instruction team for their work on the first Annual Schedule. / He reported that Fall enrollment is flat compared to this time last year and that Summer enrollment is down, especially in non-credit. / The trustees thanked Dr. Pinet for her service and for her kindness.

D. Academic Senate Report: Fred Hochstaedter, President – No report.

E. MPCEA Report: Loran Walsh, President

Mr. Wash thanked Dr. Pinet for her service. / He read from his report, which may be reviewed under "Reports."

F. MPCTA Report: Paola Gilbert, President

Ms. Gilbert introduced herself and shared her connection to and love of the community college, as well as the history of her teaching career. / She stated what can be expected of her in her new role as MPCTA President, which includes speaking for the faculty association in terms of faculty salary, benefits, and working conditions. / She spoke about the concerns of the full-time and adjunct faculty regarding their workloads and their salaries, which are among the lowest in the state, and how this negatively impacts the ability to hire new faculty.

G. ASMPC Report: Director of Representation

Student Trustee Vasquez reported that although the ASMPC is not currently in session, some members are currently working on the by-laws. / He announced that he and ASMPC President Jerry Schumann have been asked to speak at Flex Day, during which they will talk about the changes to the ASMPC and the availability for student participation. / He reported that ASMPC will be moving to the Student Center on July 16, 2014.

H. College Council Report: Stephanie Perkins and Diane Boynton, Co-chair – No report.

I. MPC Foundation

1) Executive Director Report: Ms. Beccie Michael

Ms. Michael highlighted items from her report, which may be reviewed under "Reports." / She also reported that the Foundation recently received word of a \$5,000 award from Bank of America, which she believes is in response to a grant application submitted to support the internship program. / She acknowledged Dr. Tribley for joining her at two high school scholarship ceremonies and Trustee Coppernoll for joining her at the Marina High School scholarship ceremony. She reported that the Foundation distributed five \$1,000 scholarships at each of the five local high schools.

J. Governing Board Reports

1) Community Human Services (CHS) Report – Trustee Loren Steck referred the audience to the CHS report in the Board packet.

2) Trustee Reports

a. Student Trustee Vasquez reported that he received a letter from the Superior Court of California regarding a grand jury position that he will take on next year.

b. Trustee Dunn Gustafson invited the trustees to Dr. Tom Logan's July 2<sup>nd</sup> Gentrain lecture regarding their recent trip to Jordan and his assessment of what is happening in the Middle East. / She complimented the MPC Foundation on a successful Alumni Association event and suggested that the Board send a thank you letter to Herm Edwards, Jim Tunney, and Ron Rivera for their leadership of the event. / She suggested that Dr. Tribley write a letter

to the editor highlighting the story of MPC's graduates. / She extended an invitation to join the President's Circle.

- c. Trustee Johnson commended all of the events leading up to and including graduation. / He suggested that staff look into holding a "parents weekend" for parents of new MPC students. / He invited Dr. Tribley and the trustees to participate in the July 4<sup>th</sup> parade in downtown Monterey.
- d. Trustee Coppernoll congratulated MPC Instructor James Lawrence on the accolade he received from one of his former students at the Auto Tech graduation ceremony. / She reported that she attended the MPC Foundation Board meeting and thanked the Foundation Board for approving the distribution of twenty-five scholarships to graduating high school students, instead of the five total scholarships that had previously been distributed.
- e. Trustee Steck apologized for missing the graduation events, noting that his absence was due to family business. / He reported that he attended the Community College League of California (CCLC) conference in May.
- f. Chair Brown commended Dr. Tribley and staff on the MPC graduation ceremony and Nursing graduation ceremony.

K. Legislative Advocacy Report, Dr. Walter Tribley

Dr. Tribley reported that Assembly Bill 2235 (AB 2235), which will provide the opportunity for capital funding to state institutions of education, was approved in the Senate Governance and Finance Committee without any dollar amounts tied to it. It will move to the Senate Appropriations Committee next. Dollar amounts will be reassigned by the time it comes up for a vote. If approved, MPC would be use the funds for Phase II of the Public Safety Training Center, among other things for which we may consider applying. / He reported that Senate Bill 850 (SB 850), which would enable community colleges to offer a baccalaureate degree option, is receiving resounding support throughout the state community college system. He asked if the Board wished to direct staff to draft a resolution in support of this bill, as other Boards have done. After a brief discussion amongst the trustees regarding repeatability, they spoke in support of a resolution in support of SB 850 and directed staff to bring forward a resolution in July. Dr. Tribley expressed support for SB 850 and also noted some of the challenges associated with it, including faculty salary schedules and workloads. He also indicated that he would research the status of Nursing as it relates to SB 850. / Trustee Steck stated that the MPC Foundation may be asked to contribute funds to support AB 2235 should that go on the ballot.

L. Student Success Report: "Student Success Scorecard," Dr. Rosaleen Ryan and Mr. Michael Gilmartin

Dr. Ryan and Mr. Gilmartin reviewed the 2014 Monterey Peninsula College Student Success Scorecard. / Dr. Ryan cautioned the Board to keep in mind that the scorecard doesn't include information about the numbers of students behind the percentages. In some instances, the number of students may be very low. For example, she explained that there was only one student in the cohort indicating that 100% of African-American prepared students met the completion outcome. She reported that she and other researchers are able to access information regarding the numbers of students behind the percentages.

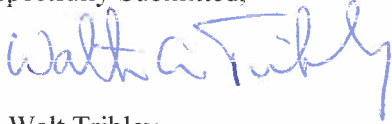
