Discussion Agenda

- Program and course outcomes revision (ongoing refinement of processes)

Fred Hochstaedter presented a slide show. In working on some courses to streamline process, we found that some faculty proposed eliminating multiple SLOs and replacing them with a single SLO. Discussion as to whether this is a good idea. There was also discussion of how to handle if the CAC Chair/SLO Coordinator and the faculty do not agree on the SLOs. One solution would be to ask faculty proponents to do a full CurricUNET course revision. The number of SLOs may vary depending on the focus and units the course contains. Cathryn noted that some schools are making their assessments public. Decision is to invite faculty to discuss at CAC meeting when there is not agreement, and if they will not discuss, we will tell them they need to do a course revision.
