2019-2020 Maximum Timeframe Appeal Process & Application

Students who have reached the 150% Maximum Timeframe, 90 or more units attempted, have failed to maintain the Satisfactory Academic Progress (SAP) Policy and are no longer eligible for State or Federal Financial Aid.

Students may file an appeal with Student Financial Services. Students must have a **special circumstance** such as:

- Accident or injury to the student
- Illness to the student that is not chronic
- **Death in the immediate family** (Immediate family means the mother, father, grandmother, grandfather, or a grandchild of the student or of the spouse, son, son-in-law, daughter, daughter-in-law, and brother, sister of the student or any relative living in the immediate household of the student.
- A onetime life altering event to the student

Students must complete the Special Circumstance section, explaining the special circumstance and attach **third party supporting documentation** such as:

- Court Order
- Police Report
- Death Certificate
- Statement from a physician

Students must complete the Education Plan Statement section and explain how they will complete their program of study successfully at MPC.

- Students must complete myAcademicPlan (MAP), General Education, and Major Education plan with an academic counselor. The counselor will provide and complete the form with the student.
- Student must have Official Transcripts from all prior colleges/universities, posted at Admissions and Records before the Appeal will be evaluated.

The Appeals Committee will evaluate the appeal and consider the special circumstance. If an appeal is approved I understand <u>I may not take any courses not listed in my education plan</u>. I understand that if I do not comply with the MPC Satisfactory Academic Progress standards I will be permanently dismissed from financial aid at MPC without the eligibility to appeal. Please note that submitting the Loss of Eligibility-Maximum Timeframe Appeal Process & Application will not guarantee an approval.
