#### 1. Please state why you are seeking appointment to the Monterey Peninsula Community College District Board of Trustees.

As a lifelong learner, I believe education is key. I naturally believe in the Mission of Monterey Peninsula College District. I have a genuine desire to improve the outcomes and bridge academic gaps in communities which District 1 serves. I am committed to helping students understand the education environment and take advantage of the great opportunity MPC offers and its gateway to transfer to a university. I wish to add to this Board of Trustee body my passion for education and community. Because of my years of engagement and commitment, a host of people, to include elected officials, previous elected officials, civic engagement leaders, parents, students/youth, family and friends strongly support and have encouraged me to go forth in this appointment process.

# 2. Please describe your willingness and availability to participate in MPC regular board meetings, MPC special board meetings, MPC events outside of scheduled board meetings, and trustee conferences.

After reviewing the MPC regular board meeting schedule I am willing and available to attend. I am fortunate to have some flexibility in my work schedule and family dynamics that will also allow me attend other special meetings and events to include traveling to conferences and retreats.

#### 3. Please describe your past and current involvement with MPC, if any.

I enrolled as a student at MPC in Fall of 1989. During that period of time, I was able to complete a significant number of units and qualified for employment through the financial aide work study program. I worked in the counseling department under the direct supervision of Debbie Anthony. During this time, I assisted with the implementation of the Career and Transfer Center. Due to my family dynamics, having two toddlers, I was forced to take a long term break in furthering my education. Some years later, I was able to return and complete necessary courses and receive an AA in General Studies and transfer to CSUMB where I received my BA in Liberal Studies on the Teaching Pathway. Soon after, I enrolled my oldest two children in MPC while they were enrolled at Monterey High. My oldest son later came to MPC as a student athlete where he too graduated and transferred to Lincoln University in Missouri and received his BA in Liberal Arts on the Education Pathway. Continuing this great family tradition with MPC, my younger son is currently attending MPC as a student athlete with plans to graduate and transfer.

# 4. Please describe your involvement with any other community or business activities that you believe are relevant to the role of a member of the MPC Board of Trustees.

A few very important roles of a member of the MPC Board of Trustees are being committed to the value of education and being active in community. I am currently actively involved in Monterey Peninsula Unified School District as a strong community voice and advocate. I attend regular and special board meetings to include the board retreats and bring information gathered back to the community. Many of my skills and much of my experience and have already been mentioned. Let me target a few areas that may not have stood out as it pertains to our Governing Board Goals for 2019. I know the importance of employing and working with an effective and visionary President. Developing relationship with the new Interim President and building rapport across the Board of Trustees is a step in achieving this goal. I come with a willingness to work with the Governing Board and learn from them as well. It is critical to be responsive and advocate for the educational needs of the community. I offer a continuous commitment in engaging the voice of the Seaside and Sand City communities, students, staff, faculty and administration. I will strive to maintain an equitable culture at MPC where student success is the focus and all employees are valued by actively listening to and meeting their needs Last but not least, I will work to find ways to increase college-wide efficiency to help ensure and secure fiscal sustainability.
