I have been privileged to serve as a teacher, principal and superintendent in four different schools at the K-12 level and have also been a music professor at the college level. Admittedly, this has all been in the private sector, but I believe there are significant similarities that would serve me well if appointed to this position. I have also served as an executive pastor of Real Life Church in Sacramento, CA, at one time overseeing six church campuses and two private schools. This involved developing and managing multi-million dollar budgets, overseeing dozens of staff members, coordinating land and building purchases, and organizing building renovations.

While I have a full schedule as a pastor, school superintendent and denominational leader, not to mention being a husband for the past thirty years to a wonderful wife as well as being a new

grandparent, I am struck by the significance of this position (I first heard it presented at a Sand City Council Meeting) and the opportunity to possibly contribute to the families of my community. I would make meetings and school events a priority, and I have the full support of my spouse in this regard.

Above all, I support the trustees in making the right decision regarding someone to serve in this position and encourage you to choose the best qualified candidate, even if that is someone other than me. 1. Please state why you are seeking appointment to the Monterey Peninsula Community College District Board of Trustees.

As a citizen of our wonderful peninsula community, I believe the way to make a better community is for people to serve the community in their areas of expertise. Personally, because of my own experiences, I believe education is the key to the future. As a long-time private school founder, high-school and college teacher, school principal, and current PK-8th grade school superintendent, I have given much of my life to education. While I am an avid proponent of trade-schools and other skill certification programs, I truly believe that a high-quality, affordable, easily accessible community college system is crucial for any society to thrive. I believe my decades of experience in education along with my graduate degrees in school administration and organizational leadership, coupled with my experience as the pastor of a multi-cultural, multi-generational church, positions me uniquely to be of benefit to our local college. I look forward to serving, learning, and becoming the best trustee I can for the good of our students.

2. Please describe your willingness and availability to participate in MPC regular board meetings, MPC special board meetings, MPC events outside of scheduled board meetings, and trustee conferences.

I am very willing to be available as needed should I be appointed to the role of Trustee. While I would be naive to assume there would never be conflicts with the other responsibilities I hold, I pledge to be committed to the trustee role and will make myself available as needed. I am quite accustomed to leading and attending board meetings in my current and previous leadership positions so the requirements of the trustee position hold no apprehension or concern for me.

3. Please describe your past and current involvement with MPC, if any.

My previous involvement has admittedly been limited as we have been focused over the past three years on returning our church and school to health. I am glad to say this has been a successful effort to date. On a personal level, my youngest daughter completed a technical program (Pharmacy Tech) at the Marina Campus, and she enjoyed the experience.

Thus far, my own involvement has been to attend graduations (supporting students from our church and other relationships), sporting events and other similar instances. I have kept an eye on MPC from a distance, reading course catalogs, listening to comments and concerns from parishioners and friends, and monitoring news items. From what I have seen, I believe MPC can have a strong future that will positively affect this community and beyond.

4. Please describe your involvement with any other community or business activities that you believe are relevant to the role of a member of the MPC Board of Trustees.

As I mentioned previously in this application, my involvement in community events has included volunteering at Del Rey Woods Elementary School for campus clean up days, volunteering at Seaside High School for Campus Clubs and similar events with Coach Avila, and opening Sand City Council meetings in prayer for Mayor Pendergrass and Mayor Carbone. Also, as previously referenced, I have been a school teacher, principal and current superintendent (Monterey Bay Christian School). I have led accreditation efforts and have developed and managed multi-million dollar non-profit and educational budgets.

5. What is your view of the role and responsibilities of a community college trustee?

The role of a trustee is not to micro-manage day-to-day operations. This should be left to the executive leader and staff. The role of a trustee (and the board as a whole) is to oversee and support the executive leadership and to ensure that the organization stays true to its vision and mission. Accordingly a trustee should help to develop, establish and maintain policies that successfully support the school, its staff, and its students.

The role of a trustee is also to represent the community as a whole, working to create a culture that is supportive of the organization and to help the organization be responsive to community needs.

6. Please describe your experience with the Brown Act and parliamentary procedures.

The Brown Act was instituted to ensure public access to information and discussion at the board meeting of government (public) agencies and organizations. This requires advance public notice of meetings and agendas. While I personally have not yet served on a board subject to the Brown Act, during our time in Fairfield, CA, my wife served as the president of the Fairfield Main Street Association which was definitely subject to the Brown Act.

The Brown Act does provide for closed sessions as necessary and allowable by law, but the results of those closed sessions must usually be made public in accordance with the law.

Specifically referring to parliamentary procedures, I have conducted several boards over the years as well as participated in many membership meetings governed by Robert's Rules of Order. Therefore, I am very familiar with parliamentary procedure.

7. What skills and experience do you have to help us achieve our Governing Board Goals for 2019?

My understanding of the current board goals include ensuring student access, success and completion of their chosen programs, pursuing diversity at al levels (including students and staff), to maintain fiscal stewardship and stability, to improve institutional quality (according to the master plan), to advocate as needed and allowed for the educational needs of our community, to increase the professional development of the board as a whole, to work well with the MPCEA and MPCTA, and to find the right superintendent who will lead MPC into the future.

Again, as a former teacher, principal, and superintendent, I understand multiple perspectives having sat in each of those chairs. Also, as a pastor of a multi-cultural, multi-generational church, I have experience communicating with and leading groups of people from all walks of life. I have served on several boards, leading most of them. I have managed multi-million dollar budgets and employees as an executive pastor while maintaining great relationships with everyone. I believe open and honest communication is the key to progress, and that would be my underlying focus as a trustee for MPC.

8. In your opinion, what are some of MPC's greatest needs and how would you help MPC meet those needs?

At the risk of sounding presumptuous as a current "outsider", what I hear from people (students especially) is their frustration at the inability to access desired classes and resources. All students (of all backgrounds, ethnicities, and diversities) should have equal access to a community college education, regardless of other factors. Education is a right for everyone. We must ensure a level playing field for every student who desires to enroll at MPC.

9. How would you engage the community to understand the needs of the institution?

I believe the responsibility of a trustee, specifically within their representative area, is to interface with everyone possible regarding the needs of MPC and its students. This includes city council members and key community leaders who hold influence. As a pastor in our city, I have many friendships with community leaders that I believe would allow me to do just that over the course of time.

10. What does diversity mean to you, and why is this important?

I believe community organizations should be reflective of the diversity within their community. Specifically, regarding a public institution such as MPC, am a firm believer that equal access should be available to everyone without restriction or impediment. The leadership, faculty, staff, and students of MPC should be a true reflection of the diversity we enjoy on the Monterey peninsula. While every person most likely has their own opinions on the socia issues of our day, discrimination of any kind has no place in a public institution such as MPC. We are a stronger community when we ensure equal access to all the people within our community.
