1. President's Report Notes

- Attended "Leading from the Middle" and the focus was on what is to come for Guided Pathways. Jeannie Kim is present to discuss more on this topic.
- Encouraged the group to attend the two forums that will take place on Monday and Tuesday (5/20 and 5/21) to listen to the candidates for MPC president.
- AAAG: The new part time faculty hiring process is under review. The draft will be coming to AS in the fall 2019 for review and discussion. There were also some recommendations for book orders and revising the faculty handbook with any

recommendations that AAAG has. AG requested that those recommendations come to AS for review and discussion.

- PAG: Discussion about a new position (Chief Human Resources Officer) that will be posted. The position is a “Chief Negotiator” and the purpose is to lead the HR office. This position is equivalent to a VP position. The position will be going to board in June for approval.

- Team 4: Communications team - has completed the drafting a formal communication plan. Once finalized, it will be presented to the campus community.
- Team 5: The program map template has been finalized. If you would like a counselor to map out a very rough draft of a program map for one of your programs please ask/there are resources available.
