### D. Head of Household Eligibility – To be completed by student

According to IRS Publication 17, an individual may be able to file as head of household if they meet <u>all</u> the following requirements:

- 1. You are unmarried or "considered unmarried" on the last day of the year.
- 2. You paid more than half the cost of keeping up a home for the year.
- 3. A qualifying person lived with you in the home for more than half the year (except for temporary absences, such as school).

If you are legally married and filed your taxes as Head of Household for 2018, you may need to file an amended tax return (form 1040X) reflecting the correct filing status. If your tax professional indicated that you were eligible to file as head of household (despite being married); please continue to complete this form and, if available, provide a statement from your tax professional on their company letterhead.

Initial next to each of the following requirements, only if the requirement is applicable to your tax filing circumstances.		
Considered Unmarried Eligibility Requirements		
You filed a separate return.		
You paid more than half the cost of keeping up your home for the tax year.		
Your spouse did not live in your home during the last 6 months of the tax year. Your spouse is		
considered to live in your home even if he or she is temporarily absent due to special circumstances.		
Your home was the main home of your child, stepchild, or foster child for more than half the year.		
You must be able to claim an exemption for the child. However, you meet this test if you cannot claim the exemption only because the non-custodial parent can claim the child.		
Head of Household Eligibility Requirements		
You were married but considered unmarried on December 31, 2018 (If you initialed <u>all</u> of the previous criteria initial here)		
You paid more than half the cost to keeping up your home for the tax year.		
A qualifying person lived with you in the home for more than half the year (except for temporary absences, such as		
school). However, if the qualifying person is your dependent parent, he or she does not have to live with you.		
<b>E. Personal Statement</b> – Explain in detail why you were allowed to use that filing status given your marital status and,		
if available, please provide a letter of explanation from your tax preparer or the IRS.		
<b>F. Certification and Signatures</b> – Each person signing this worksheet certifies that all of the information reported on it is complete and correct.
