

## 2020 Summer Aid Information

### **TO BE CONSIDERED FOR SUMMER FINANCIAL AID AT MPC YOU MUST**

1. If you *are a continuing MPC student* who received aid for fall and/or spring semesters for 2019-2020
  - Register for all of your summer classes.
  - Submit the 2020 Summer Financial Aid Request form (available NOW)

**PLEASE NOTE:** If you attended MPC during spring semester 2020, your summer aid **cannot** disburse until:

  - i. ALL grades for ALL students are posted AND,
  - ii. The Financial Aid Satisfactory Academic Progress process has been run.
2. If you *did not attend MPC* in the 2019-2020 academic year or you attended MPC but have not yet filled out the 2019-2020 FAFSA:
  - Complete and submit the 2019-2020 Free Application for Federal Student Aid (FAFSA) at [www.fafsa.ed.gov](http://www.fafsa.ed.gov) listing MPC's school code (001242) [*if you attended a different school in 2019- 2020 and received aid there, please add MPC's school code to your FAFSA*]
  - Follow through with the Financial Aid office to get your FAFSA processed quickly
  - Register for all of your summer classes
  - Submit the 2020 Summer Financial Aid Request form
3. Complete and submit the 2020-2021 Free Application for Federal Student Aid (FAFSA) at [www.fafsa.ed.gov](http://www.fafsa.ed.gov) listing MPC's school code (001242)

### **JUNE 30 DEADLINE:**

**If you have not yet filed the 2019-2020 [FAFSA](#) or the 2019-2020 California Dream Act Application, you MUST submit before June 30, 2020.**

#### **AID THAT IS AVAILABLE THIS SUMMER**

- California Community College Promise Grant (BOG Fee Waiver) for eligible students
- Pell Grant if you have eligibility left from your 2019-2020 award

#### **TIMING OF SUMMER DISBURSEMENTS --**

If you attended MPC during spring semester 2020, your summer aid **cannot** disburse until:

- ALL grades for ALL students are posted AND,
- The Financial Aid Satisfactory Academic Progress process has been run.
- Summer aid **will not** be disbursed to you until **you** begin classes.
