Standard Writing Teams

The Standards Writing Teams are organized around the ACCJC Standards. The team for each of the main standards consists of a Standard Lead to provide support and guidance; lead writer(s) for each of the subsections within the main standard; and a group of "area experts" who can provide information or similar support for the lead writers.

Standard Team Roles

- Standard Leads work with the lead writers of the sections within their standard, oversee
 the direction of the drafts, do first-line editing of sub-section drafts as they are
 completed, and communicate information and updates to writers that would affect the
 draft-writing process.
- Lead writers are responsible for preparing the first draft of writing of their sub-section and for incorporating feedback from the leadership team into the second draft.
- Area experts serve primarily as information resources. At the very least, they should be
 interviewed by the lead writer. They may end up writing small portions of the subsection
 (at the discretion of the lead writer). Area experts will help to identify and prepare key
 pieces of evidence to support the narrative of the sub-section. Since there is some
 overlap in the areas addressed by the standards, Area experts may be asked to provide
 information for more than one team.
