## EMMS 170A: EMERGENCY MEDICAL TECHNICIAN I: BASIC TRAINING

Techniques of emergency medical care designed to meet the State of California Requirements for certification of EMT-I Basic personnel. Emergency Medical Technician Basic Training designed to meet Department of Transportation, National Registry of EMTs, and State of California requirements for certification as an EMT-Basic.

#### <u>EMMS 170B</u>: EMERGENCY MEDICAL TECHNICIAN I: BASIC TRAINING APPLICATION

Participation includes a ride along with a local provider, patient observation in the hospital setting and preparation for the National Registry skills and written test. Hours are by arrangement.

## **CLASS SCHEDULE**

The Emergency Medical Technician course (EMMS 170A/B)

is 16 weeks in length and offered twice per calendar year (Spring and Fall semester). The course schedule consists of 2 nights a week of either Monday/Wednesday or Tuesday/Thursday from 6PM to 10PM and a skills lab one weekend day a month + 24 hours of clinical observations.

The EMT program is a two course co-requisite consisting of EMMS 170A and EMMS 170B (9 units for a total of 204 hours) that must be taken concurrently.

Once you graduate from the EMT program, you will be eligible to apply to take the National Registry of Emergency Medical Technicians (NREMT) exam and apply for state EMT certification.

\*\*Students are required to provide proof of cleared criminal background, drug screen, AHA BLS CPR card and current vaccinations. Contact the PSTC for a full list of requirements.
