Notes (taken by Gamble Madsen) based on commentary offered by Dawn Rae Davis (3:07 – 3:18 pm)*:

Speaker has provided information to further the work of CAC – there is no intention to malign any MPC employee

Speaker requests that CAC agendize a discussion regarding procedure when guidelines [for revising cross-listed courses] are not followed

- Emphasis on collaboration and conversation, clear indication of sequential order; both departments must discuss the proposal (including rationale), action(s) in case of disagreement follow this discussion

Speaker recalled a meeting regarding collaboration on the cross-listing between GWOS 12 and HIST 12, held May 23, 2023 (with Jon Knolle)

- A proposal to sever the cross-listing was created soon after this meeting, based on what the History Department Chair deemed 'best for History students' and an 'irresolvable disagreement' between Departments
 - Speaker asserted that this proposal has not been vetted at the Discipline level; there has been no discussion, no provision of a rationale for severance from the History Chair, and no input solicited from GWOS

*Speaker was asked by CAC Chair (Gamble Madsen) to stop their commentary at 3:18 pm (previous email communication had identified ten minutes total for their public comments), with invitation to share entire text of their presentation with the Chair for distribution to committee members via email. For Distribution. From CAC Guideline for Cross-listed Course Revision (authored and approved by CAC, vetted and approved by Academic Senate)

Issues to consider and requirements for revising or separating cross-listed courses: Faculty hold purview over curriculum in their departments. **Collaboration** between faculty is <u>essential</u> in the development of cross-listed courses, <u>as are conversations</u> when deciding to revise cross-listed courses, <u>since</u> these **involve two or more disciplines**. If it is determined that a change is necessary to a cross-listed course, the departments <u>must discuss</u> it and <u>co-author the revision proposal</u>.

[In order] To separate cross-listed courses, <u>both</u> departments should <u>discuss</u> the rationale for severance...This decision should be made with reference to course content and objectives, and in
