22 working days of vacation are authorized each year, with an accrual maximum of 44 days.

An additional 10 working days are authorized beyond the normal vacation for study, travel and general professional improvement for Vice Presidents.

A monthly stipend of \$273 will be awarded for an earned doctorate from an accredited institution.

An additional 5% stipend may be earned by an administrator for each District negotiating team in which they have been assigned to serve. *This 5% stipend does not apply to Vice Presidents.*

The Vice Presidents and all educational administrators are placed on individual contracts. In special circumstances, such as grant-funded or limited funding, certain classified administrators may also be placed on individual contracts.

All positions are overtime exempt.
