| <b>Discussion<br/>SB 1440<br/><br/>Michael Gilmartin</b> | <p>Michael presented an overview of SB 1440, now part of the California Education Code (§66746), which mandates all California Community Colleges develop associate degrees for transfer to the CSU system. He explained the Transfer Model Curriculum (TMC) which has been developed to facilitate community college development of such degrees, what the degrees must contain, that local requirements may not be included in these degrees, and that at least two such degrees must be approved and in place by Fall 2011. Students will benefit from completing these programs by receiving, among other guarantees, admission preference into the CSU system upon graduation.</p> <p>The first two TMC programs that the college will be submitting for approval will be Psychology and Communication Studies.</p> | FYI – Discussion will continue   |
